I. ABOUT STATE RESOURCE CENTRE FOR WOMEN(SRCW)

The State Resource Centre for Women (SRCW) was set up in September, 2012. The State Resource Centre for Women spearheads the activities of the Mission on the State for holistic empowerment of women that includes Social Empowerment, Economic Empowerment, Legal Empowerment and Political Empowerment. It will facilitate Government and other Stakeholders involved in women empowerment issues to implement gender sensitive programmes, laws and schemes through effective coordination. SRCW reviews and evaluate existing policies, programmes and legislations impacting women and bring suitable recommendations before the Executive Committee for suitable measures. SRCW handholds and monitors the implementation of the Pilot convergence projects in the State. It also works for the convergence of women centric Schemes/Programmes of various Central and State Government. It ensures that violence against women is eliminated progressively and reviews existing legislations and provisions related to violence Against Women (VAW). It undertakes awareness generation as well as advocacy activities to fuel the demand structures at district, block and village levels with the involvement of village committees, durbars for their fulfillment. It also holds the District Convergence and Facilitation Centre pilot project in the selected district of Jaintia Hills. SRCW also monitors the implementation of PSK at Laskein Block, VCFS under BBBP at Ri Bhoi District, Womens Helpline and One Stop Centre OSC. SRCW also undertakes Research and IEC activities
